ORDER

The 1st hearing held on **28th November, 2024** related to the **APIC-No-239/2024**. The Appellant Shri Pisa Tapam is present in person. The PIO-cum-EE, Lhou Hydro power Division-I, DHPE, Lhou, District Tawang, authorized Shri Tumbom Angu (APIO) to appear in the hearing.

Heard the Appellant and the APIO: The Appellant stated that no information(s) has been provided to him by the PIO till date.

The representative of the PIO, Shri Tumbom Angu (A.E) informed the Commission that some of the information(s) sought by the Appellant in Form-A application are not under the jurisdiction of the PIO, except S/Nos. 1, 5, 6, 10, 11, 12 and 16.

The Commission ordered:
