ORDER

The 4th hearing held on **17th July, 2025** related to the **APIC No-646/2023**. The Appellant Shri Tamchi Gungte is present. The PIO-cum-EE, PHE & WS, Kodhuka Division, Upper Subansiri District, Govt. of Arunachal Pradesh, is represented by Shri Limin Ete,(JE) PHE & WS, Kodhuka Division, with an authorization letter during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the information(s) pertaining to Serial No. 8 has not been provided and for Serial Nos. 9 and 11 also, in-complete information(s) have been provided.

Heard the representative of the PIO;

The representative of the PIO stated before the Commission that he has brought an affidavit by the PIO to be provided to the Appellant pertaining to Serial No. 8 of the Form-A application of the Appellant, stating that the information has not been found or misplaced.

After hearing both the parties: **The Commission observes;**

The PIO cannot deny the information(s) to the Appellant simply by giving an affidavit that the information is misplaced or lost. **Therefore, the Commission hereby orders;**

- i) The PIO to provide the information(s) applied in Serial Nos. 8 of the Form-A of the Appellant and information(s) for Serial Nos. 9 & 11 to be provided completely to the Appellant on or before the next date of hearing and to attend the next date of hearing without fail, failing which necessary action will be initiated against the PIO as provided in the RTI, Act, 2005.
- ii) The Appellant to intimate the Commission in the event of receiving the information(s) from the PIO on or before the next date of hearing and to be present in the next date of hearing, failing which this instant appeal will be heard and determine ex-parte.
- iii) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 28th October, 2025' at 2:30 PM (Evening).


