WHEREAS, in connection with the **APIC-No. 114/2024**, your personal appearance is required before the Commission on **05th September, 2024 at 10:30 AM**. Both the parties, the Appellant Shri Riya Taram and his party and the PIO found absent without intimating to the Commission the reason for their inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act, 2005, which is a statutory duty binding upon the PIO. And the appellant absenting in the hearing without intimation to the Commission, of his inability to attend the hearing makes the Commission deem that the Appellant is not serious on his appeal.

The Commission has viewed seriously on the absence of both the parties and their reluctant attitude for not complying the orders of this Court, the Commission ordered;

(i) To issue **warning Summon notice** to both the parties to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.**

(ii) The Appellant to collect remaining information(s) from the PIO's office immediately after depositing the requisite fees. **Failing which his appeal shall be decided -ex-parte.**

The next date of hearing is fixed on 5th September, 2024 at 10:30 AM (Morning)

It is so ordered this 6th day of August, 2024 at 4:30 PM.
