An Appeal Case U/S 19(3) of RTI Act, 2005

APPELLANT : Shri Tamchi Gungte, near KV-II School Itanagar.

RESPONDENT : The PIO, o/o the Executive Engineer, RWD, Hawaii Division, Anjaw District (A.P)

ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 30 point information C/o "L025-PMGSY Road from PMGSY Road (Staging Hut Krosam to Khrawit village during the financial year 2024-25 by the PIO, o/o the Executive Engineer, RWD, Hawaii Division, District Anjaw, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.11.2024.

Hearing and decision:

This appeal was heard for 3(three) times earlier on 04.06.2025, 23.07.2025 and 23.07.2025. On 4th June, 2025, wherein the appellant was present in person and the PIO, Er. Shri Bajai Pul, EE was present through VC, this Commission, after hearing the parties had directed the PIO to provide the information duly indexed and countersigned.

The appellant, vide letter dt.17.06.2025, informed that he has received the documents from the PIO on 07.06.2025, but complained that the following documents are either not furnished or are incomplete /unsatisfactory.

- 31. Sl. No.1: Not furnished;
- 32. Sl. No.4 and 5 : Replies not justified;
- 33. Sl.No.6, 10, 12, 16,17 and 18 : Not furnished;
- 34. Sl.No.19,29,21,25,26 and 27: Not satisfied with the replies.

This appeal was, therefore, listed again on 23.07.2025 but the appellant was absent and hence, the hearing was adjourned to 27.08.2025.

Today on 27.08.2025, both the PIO, Er. Shri Bajai Pul, EE and the appellant, Shri Tamchi Gungte are present in person.

Heard the parties.

As regards the copy of sanction order (Sl. No.1), the PIO submitted that other than the sanction order received from the GoI, no sanction order from the State Govt. has been issued in respect of the project in the instant case.

As regards Sl.Nos. 4, 5, 25, 26 and 27, the PIO clarified that since the execution of the project in question has not yet commenced, the requested information have not been furnished but the same will be furnished in due course.

As regards Sl. Nos. 6(NIT), 10(Design),12 (Technical Bid documents) and 16(Enlistment certificate of the Contractor winning the tender), the PIO assured to furnish the same.

As regards Sl. Nos.18 (integrity pact) and 19(affidavit), the PIO submitted that the documents were not obtained from the contractor.

The rest of the left out documents have been furnished by the PIO during the course of hearing with which the appellant has expressed his satisfaction.

This Commission, after hearing the parties and perusing the documents furnished by the PIO, directs the PIO to furnish the left out documents to the appellant before 26.09.2025 and report its compliance on 26.09.2025 the next date of hearing.

NOW THEREFORE, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on 26.09.2025 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
