

## **ORDER**

The 2<sup>nd</sup> hearing held on 31<sup>st</sup> July, 2025 related to the APIC No-14/2025. The Appellant Shri Tamchi Gungte is present. The PIO-cum-Executive Engineer, PWD, Naharlagun Division, Papumpare District, Govt. of Arunachal Pradesh, found absent for the consecutive 2<sup>nd</sup> time during the hearing, without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

The PIO absent consecutively 2<sup>nd</sup> time today, despite of notices for hearing being issued to the PIO on 14.02.2025 and 06.04.2025. The absence of the PIO consecutively has compelled the Commission to secure the attendance of the PIO to hear the appeal against him in the court of the Commission.

Taking serious note of the absence of the PIO for the 2<sup>nd</sup> consecutive time despite summons being issued to him, **the Commission hereby orders as follows;**

- i) To issue Bailable Warrant of arrest to the PIO-cum-Executive Engineer, (PWD) Naharlagun Division, Papumpare District, for securing his attendance in the Third Hearing of this appeal, which is on **11<sup>th</sup> day of November' 2025 at 2:30 PM.**
- ii) To issue notice of this bailable warrant of arrest to the Officer-In-Charge, Naharlagun Police Station, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **11.11.2025, at 2:30 PM, without fail,** before this court.
- iii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Naharlagun, Papumpare District for compliance.
- iv) The copy of this bailable warrant of arrest be served to the Deputy Commissioner, Itanagar Capital Region (ICR), Papumpare District for compliance.
- v) Notice for the next date of hearing need not be served to the Appellant as he is present during the hearing today.

**The next date of hearing be fixed on 11<sup>th</sup> November, 2025' at 2:30 PM (Evening).**
