ORDER

The 1st hearing held on <u>21st August</u>, <u>2025</u>² related to the <u>APIC No-221/A/2025</u>. Both the parties are present personally during the hearing before the Commission.

Heard the Appellant;

The Appellant stated before the Commission that he is yet to receive the information(s) from the office of the PIO regarding construction of restoration and empowerment of road drainage under Kalaktang wownship for the year 2021-22.

Heard the PIO;

The PIO stated that the Appellant has filed 14 numbers of applications on 10/11/2024 and 11 numbers on 19/10/2024 totaling to 25 numbers of applications regarding multiple schemes and projects that we have executed under the division of the PIO, in such situation, receiving 25 numbers of application from a single individual and then there are lots of many other individuals who file multiple applications for multiple schemes for multiple years. Under such circumstances, the office of the PIO is not able to deliver its duties on time, as at time some of the applications get misplaced. But still under such condition also the PIO stated that the information(s) as sought by the Appellant are ready in his office and so requested the Appellant to come in person to the office and collect it from the office, as Postal Department Services take so much time to deliver.

The Appellant too has agreed that he will personally go and collect the information(s) from the office of the PIO.

To ascertain the complete receipt of the information(s) the Commission hereby orders as follows;

- (i) To fix the next date of hearing.
- (ii) The Appellant be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- (iii) The PIO be present in person or through online mode without fail in the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 27^{th} November, 2025' at 10:30 AM (Morning).
