ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tashi Tsering, S/O Lt. Genden Tsering, resident of Lebrang Village, Tawang, PO, PS and District Tawang, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., Department of PHED, Tawang Division, Tawang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 30/04/2024 regarding payments made through cash and cheque for amount of more than Rs. 50, 000/- to firms / individuals.
- 2). The 2nd hearing was held on 29th April, 2025. The Public Information Officer, Govt. of A.P., Department of PHED, Tawang Division, Tawang District, Arunachal Pradesh was represented by Shri Jobom Bam, JE(PHE & WS) Tawang Division. The Appellant Shri Tashi Tsering had appeared before the Court through Video Conferencing.
- 3). The Commission had directed the PIO to furnish Cheque counter foil Xerox copies to the Appellant within 30(thirty) days from the date of issue of the order dated 29th April, 2025. The Appellant was also directed to intimate to the Commission after receipt of the information for disposal of the case. Further, the Appellant was advised to apply fresh application in Form-A to the PIO if additional information were required.
- 4). The Appellant has been given reasonable time to intimate his satisfaction or dissatisfaction regarding the information furnished by the PIO but till date the Appellant has not submitted any intimation to the Commission. The Commission hereby decides to dispose of the case.

5).Therefore, the case is hereby disposed of.
