ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Taru Dobin, Chimpu-I, Mithun Hapa Colony, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Department of Public Works, Daporijo Division, District Upper Subansiri, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/04/2025 regarding Campus development of Indoor Stadium of Daporijo.
- 2). The 1st hearing was held on 2nd September' 2025 as scheduled. Shri Lardik Kare, PIOcum-EE(PWD), Govt. of A.P., Department of Public Works, Daporijo Division, District Upper Subansiri, Arunachal Pradesh appeared before the Commission through online video conferencing. The Appellant Shri Taru Dobin was present in person.
- 3). The Appellant submitted that the PIO had not furnished any information except for the DPR. Also, the PIO was absent during the hearing before the hon'ble court of FAA.
- 4). The PIO submitted that the Form-A application of the Appellant was received on 21st April'2025 and reply was given to the Appellant on 6th May'2025, i.e. within the stipulated time. That the Appellant was furnished with available information like DPR, and sanction order. That, the Utilization Certificate (U.C.) and work order could not be furnished as the project is ongoing and the work order against the project does not exist as the work was allotted through tendering process. And that the information sought at Sl.no. 3 was not specific and hence, Appellant was asked to be more specific in his request for information.

- 5). The Commission advised the Appellant to do little homework and apply afresh Application in Form-A to the PIO within ten days from the issue of this order, with more clarity and specification.
- 6). The Commission also directed the PIO to furnish information within thirty days from the receipt of the Form-A from the Appellant, failing which penal action under section 20(1) of the RTI Act, 2005 would be imposed on the PIO. The Appellant was also asked to intimate his satisfaction or dissatisfaction after receipt of information.
- 7). The next date would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
