ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV2 School, Chimpu, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A dated 09/10/2024 regarding Construction of Road from PWD Road to Pekimodi in Upper Siang District (22.11km) under North East Special Infrastructure Development Schemes(Road) during the financial year 2024-25.
- 2). The 2nd hearing was held on 15th July' 2025. Shri Bom Borang, the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh had attended the court hearing through online video conferencing. The Appellant was present in person before the Commission's court.
- 3). The Commission had then directed the PIO to forward copies of letters submitted by the third parties to the Commission and advised the third parties to appeal to the Commission under section 19(4) of the RTI Act. Also, furnish all the available information against the Sl.no. **2, 7, 8, 10, & 11 of the Form-A dated 09/10/2024** and to give justifiable reasons for any information not furnished to the Appellant.
- 4). The Appellant vide letter No. nil dated 30/07/2025 submitted that the PIO failed to furnish complete information as directed and appealed the Commission to take necessary action against the PIO under relevant section of the RTI Act. The Appellant also appealed for the fixation of next date of hearing.
- 5). The Commission observes that the PIO has failed to comply with the directions, therefore next date of hearing is fixed to hear from the PIO.
- 6). **The next date of hearing is fixed on 9th September'2025 (Tuesday) at 1100hrs.**

9). Shri Bom Borang, the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through video conferencing on the scheduled date and time without fail. Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.


