ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Smt. Bengia Rina & Shri Bengia Tani for non-furnishing of 16(sixteen) point information regarding the c/o Community Hall at new Bazar, Koloriang by the PIO, o/o the Executive Engineer (PWD), Sangram Division, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.10.2024.

This appeal was, accordingly, listed and heard on 11th June, 2025 wherein the Appellants were absent but Shri Bini Tare, PA attended the hearing in person on behalf of the PIO.

Since the appellants were absent, this Commission could not get the confirmation from the appellants as to whether or not they have received the requested documents from the PIO in terms of the order passed by the FAA.

The hearing of this appeal was, thus, adjourned to today on 16th July, 2025 wherein Shri Bini Tare, the representative of the PIO was present in person and one of the appellants Shri Bengia Tani appeared through VC.

This Commission noticed that the representative of the PIO brought in some documents but on perusal it was found that the documents were related to some other RTI application.

This Commission, therefore, adjourned the hearing to 01.08.2025 and directed the representative of the PIO to furnish the requested documents in complete and satisfactory form to the appellant within 15 days from the date of receipt of this order and report compliance thereof in the hearing on 01.08.2025. The appellants were also directed to collect the documents from the o/o the PIO and intimate the receipt thereof and also attend the next hearing **in person making it clear that his failure to comply the order shall entail** disposal and closure of the appeal presuming that they are satisfied with the documents.

In today's hearing the representative of the PIO, Shri Bini Tare is present with the documents but the appellant, Shri Bengia Tani appeared through the VC despite order of this Commission to appear in person. The appellant, however, complained that inspite of his repeated efforts to contact the PIO, the PIO or the representative of the PIO, his calls were not responded.

This Commission after hearing the parties, directed the appellant to collect the documents from the representative on 04.08.2025 who shall be present in this Commission's office with the documents and intimate this Commission of the receipt of the documents and his satisfaction or otherwise therewith failing which this appeal shall stand closed.
