**ORDER**

The 5<sup>th</sup> hearing held on **28<sup>th</sup> August, 2025** related to the **APIC No-228/2024**. The Appellant Shri Gida Tapam is present during the hearing before the Commission.

The PIO-cum-EE, PHE & WS, Sangram Layang Division is represented by his APIO Shri Tai Doru, Assistant Engineer, PHE & WS, Sub-division Sangram, Govt. of Arunachal Pradesh during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that in reply to his Form-A list of information(s) sought in Serial No. 1 the PIO has stated that no tender was floated because the public and Panchayat of the area where the scheme/project to be implemented decided through a general meeting to carry out the work by the villagers themselves by issue of work order without calling for tender.

The PIO has furnished a list of names of person who had attended the meeting but he has not furnished a signed copy of the members who were present in the meeting, to decide the 11 (eleven) crore project be executed through work order basis without floating tender, therefore, the members present list with their signature be furnished to the Appellant. For the rest of the information(s), the PIO has furnished to him.

**Heard the APIO;**

The APIO stated that almost all the information(s) have been furnished and remaining information will be provided to the Appellant before the next date of hearing.

**After hearing both the parties, the Commission hereby orders as follows;**

- i) The PIO to provide the list of persons along with their signature who were present in the meeting to decide that the scheme P/W/S at Langrh, Nyabia Circle H.Q including adjoining villages such as Pagam, Pachang, Bagang & Hagar be executed through work order system by the villagers.
- ii) The PIO to provide the name and address of the Firm owner those who were awarded the work to execute the project along with a copy of the trading license of the firms that executed the works.

- iii) The PIO to furnish the information(s) on or before the next date of hearing without fail, failing which action will be initiated against him as per the provisions of RTI, Act, 2005.
- iv) The Appellant be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- v) Notice need not be served to both the parties as they are present during the hearing before the Commission.

**The Commission hereby orders;**

**The next date of hearing be fixed on 9<sup>th</sup> December, 2025' at 1:30 PM (Evening).**
