An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-302 /2025.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram and 2 others for non-furnishing of 17 (seventeen) point information on the projects implemented under the PMKSY/HKKP from 2016-2025 by the PIO, o/o the Executive Engineer (WRD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 20-01-2025.

Brief facts and decision:

Records emerging from the appeal disclose that the appellants, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to file their 1st appeal before the Chief Engineer (WRD), Eastern Zone, Miao, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 instead of Western Zone, Itanagar vide Memo of Appeal dt. 21.02.2025. The appellants having failed to obtain the information preferred their 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 24.03.2025.

This appeal is, accordingly, listed today on 20th August, 2025 wherein the PIO, Er. Shri Yaakar Ngomdir, E.E.(WRD), Daporijo is present vis VC but the appellants are absent.

Herad the PIO who, while reiterating his submission vide his letter dt.30.04.2025, that the requested information is voluminous, pleaded for appropriate direction to the appellants to specify particular details of information to enable him to provide the most relevant information.

This Commission, upon hearing the PIO and the points on which the appellants had sought the information, notices that the requested information/documents are infact voluminous and therefore, directs the appellants to prioritise their demand and reduce the number of years so as to enable the o/o the PIO to collect the information without adversely affecting the smooth functioning his office.

The appellants shall intimate the o/o the PIO seeking relevant information by prioritising the points within 1(one) week from the date of this order and thereafter the PIO shall furnish the information within 1(one) month whereafter the appellants shall intimate this Commission of the receipt of the same within one week failing which this appeal shall stand closed.
