ORDER.

The 6th hearing was held on 18th August, 2025 related to the **APIC No-1028/2023 (Appeal)**. The appellant Shri Mamu Sono present in person but the PIO-cum-Executive Engineer (IMC) Part-II, Naharlagun found absent without any intimation to the Commission.

It is seen from the case record that the PIO-cum-Executive Engineer (IMC) Part-II, Naharlagun Sub-Division, is absent consecutively 5 (five) hearings dated 02/12/2024, 13/01/2025, 24/02/2025, 26/03/2025 and 28/04/2025.

As per the case record, penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only was imposed against the PIO for violation of Sub-Section-1 of Section-7 of RTI Act, 2005, but till date the PIO has not deposited the penalty amounts nor provide any information as sought by the appellant. Last chance is given to the PIO to appear before the Commission and deposit the treasury challan copy of penalty amount. The PIO was also directed to compensate to the appellant an amount of Rs. 5,000/- (Rupees five thousand) only but he failed to comply the direction of the Commission. **If the PIO is absent in the next hearing, Warrant Arrest under Order-XVI, Rule 10(3) CPC, 1908 R/W Section 18(3) of RTI Act, 2005 will be issued against the PIO to compel his appearance.**

The Commission fixed next date of hearing on **29/09/2025 at 1030 hours.**
