Information sought:

The appellant filed an RTI application dated 04.02.2025 seeking all the relevant information under RTI Act 2005 in respect of Forest Department of State CAMPA, CSS and State Plan under Likabali Forest Division.

1. Furnish CTCs of lists of all the works taken up from various heads (State CAMPA, CSS, and State Plan) under Likabali Forest Division from 2018-19 to 2024-25.
2. Furnish CTCs of payment details of all the funds received from various heads (State CAMPA, CSS, and State Plan) from 2018-19 to till date.
3. Furnish CICs of list of sawmills established under the jurisdiction of Likabali Forest Division till date.
4. Furnish CTCs of list of Forest Reserves (Anchal Forest Reserve, Propose Forest Reserve, and Forest Reserve) under Likabali Forest Division along with Map.
5. Furnish CICs of seizure reports of all illegal timber under Likabali Forest Division from 2019-20 to till date.
6. Furnish CTCs of list of Crushers established under the jurisdiction of Likabali Forest Division till date along with copies of NoCs issued for the same.

7. Furnish CTCs of list of Quarries along with copies Nols given issued for the same under Likabali Forest Division till date.
8. Furnish details of all the mining related industries/factories established under the jurisdiction of Likabali Forest Divisions with date of establishment till date.
