**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/ PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( PWD ), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 17/01/2025 regarding Improvement of Bomjir-Paglam road (Bizari to Anpum, L-13.400 Km) 2021-22.
- 2). **The 1<sup>st</sup> hearing was held on 5<sup>th</sup> August' 2025 as scheduled.** Shri Kini Zirido, the PIO-cum-EE( PWD ), Govt. of A.P., Roing Division, Lower Dibang Valley District, Arunachal Pradesh was represented by Shri Vikash Bagang, JE (PWD) , Roing Division. The Appellant Shri Tamchi Gungte was present.
- 3). The Appellant had submitted that the information furnished were incomplete. For Sl.no. 1, only the PRC of the tender winner had been furnished and **other tender participants' PRC had not been furnished.** For Sl.no. 2, some progress report had been furnished and for Sl.no. 3, complete documents submitted by the tender participant for Technical Bid had not been furnished.
- 4). The Commission therefore, directed the PIO to furnish all the available information as sought by the Appellant and that in case information were not available, justifiable reasons be furnished through an AFFIDAVIT. It was further directed that the information had to be furnished within twenty days from the date of issue of the order.
- 5). However, the Appellant vide letter dated 25/08/2025 has informed the Commission that the PIO had not furnished the information as directed by the Commission and therefore, appealed the Commission to take action against the PIO and fix one more date of hearing.

6). Therefore, the next date of hearing is fixed on 30<sup>th</sup> September'2025 (Tuesday) at 1100hrs .
