ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/ PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Construction / up gradation of roads and Bridge under Pradhan Mantri Gram Sadak Yojana during the financial year 2024-25.
- 2). The 2nd hearing was held on 19th August, 2025. Shri R. W. Zimik, the PIO-cum-EE(RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh and the Appellant Shri Tamchi Gungte were present.
- 3). The PIO submitted that he could not attend the 1st hearing due to DLMC meeting held on same date. The PIO also informed that there was bifurcation of the division and all the records had not been handed over to him by the previous officer. However, the PIO assured that he will collect and furnish available information to the Appellant.
- 4). The Commission directed the PIO to give priority to statutory duty over other duties and cautioned not to absent himself from a court hearing in future. Also, directed the PIO to furnish all the information as sought by the Appellant in the Form-A dated 05/02/2025 within 15(fifteen) days from the date of issue of this order. In case information are not available in the records the PIO was directed to give justifiable reasons through AFFIDAVIT. The Commission also directed the Appellant to collect information from the office of the PIO and intimate his satisfaction or dissatisfaction to the Commission within 20 (twenty) days from the date of issue of this order, failing which the case would be disposed of.
