ORDER

The 1st hearing held on **5th August, 2025** related to the **APIC No-139/2025**. Both the parties are present during the hearing before the Commission. .

Heard the Appellant;

The Appellant stated that the information(s) have been provided to her but they are incomplete.

Heard the PIO;

The PIO stated before the Commission that the information(s) sought is voluminous to be provided to the Appellant, so he could not provide within prescribed period of 30 days, then the Appellant preferred the First Appeal in the First Appellate Authority (FAA)-cum-Chief Engineer, PWD, Central Zone-B, on which the FAA get the judgment as disposed of on 29.01.2025 for the reason that in the 3rd hearing the Appellant was absent without intimation to the FAA the reason for her absence.

The Commission observes;

Going through the judgment order of the FAA and after hearing the both parties, the Commission found that She has attend first and second hearing before the First Appellate Authority (FAA), but in third hearing she was absent with intimation the reason for her absence. Therefore, the judgment of the FAA is over-rule.

The Commission hereby orders;

- i) The PIO to provide only one block year to the Appellant under her Form-A application, pertaining to Serial Nos. 1, 2, 4, 7, 8, 9 and 10 for the year 2018 to 2019 on or before the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
- ii) The Appellant to be intimated to the Commission to let know that the information(s) have been received completely or not, on or before the next date of hearing and to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- iii) Notice need not be issued to the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 13th November, 2025' at 10:30 AM (Morning).


