<u>ORDER</u>

WHEREAS, in connection with the APIC-No. 190/2025, your personal appearance is required before the Commission on 27th November, 2025 at 10:30 AM. The 1st hearing held on 21st August '2025. The Appellant Shri Mamu Sono present during the hearing but PIO -cum Executive Engineer (PWD) Dirang, found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Commission that the PIO has not furnished any of the information(s) as sought by him in his form 'A' application till date.

After hearing the Appellant, the Commission seriously viewed the absence of PIO and ordered;

- To issue summons to the PIO to appear in person or through online mode before (i) the Commission in the next date of hearing.
- The PIO to provide all the information(s) to the Appellant on or before nest date (ii) of hearing as sought in his forma 'A' application . Failing which necessary action shall be initiated against the PIO as the provision of RTI Act 2005.
- The next date of hearing has been intimated to the Appellant. No formal notice (iii) required to issued.

The Commission ordered;

The next date of hearing be fixed on 27th Nov'2025 at 10:30 AM (morning)
