ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by Shri Pokter Rime, the PIO –cum-DDSE, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

2). The 17th hearing was held on 19th August'2025. Shri Pokter Rime, the SPIO –cum-DDSE, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh was represented by Shri Take Hali, APIO-cum-DA, o/o the DDSE Daporijo. The Appellant Shri Nabam Tapak was absent.

3). The APIO submitted that all the information and AFFADIVIT had already been furnished to the Appellant and the case was disposed of vide Memo No. APIC-356/2022/590 dated, Itanagar the 14th February'2025. The APIO also produced receipt of the Appellant.

4). Though the case was disposed of, the Commission had fixed the hearing to ensure supply of information to the Appellant as the Appellant had submitted a request through letter no. nil dated 08/07/2025. The Commission decides to dispose of the case, in view of submission made by the APIO and on perusal of receipt record of the Appellant.

5). The case is hereby disposed of with liberty to the Appellant to file writ petition before the Hon'ble High Court, under article 226 of the Indian Constitution, if not satisfied with decision of the Commission.
