Information sought:

The appellant filed an RTI application dated 23.04.2025 seeking all the relevant information in respect to C/o "The total list of projects sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India" during the financial year 2016-17.

The total list of Projects are as follows:-

1. Construction of RCC additional room at CHC Mechuka in Mechuka block of West Siang Dist. Arunachal Pradesh. (2016-17).
2. Construction of RCC 40 bedded Girls Hostel in Middle/Secondary schools at various location of Gensi block of West Siang Dist. (2016-17).

Particulars of sought information are given below: -

1. Furnish the certified Sanction Order Copy.
2. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status within the district as per Rule 4(ii) (b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
3. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020,
4. Furnish the certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
5. Furnish the certified copy of Utilization Certificate.
6. Furnish the details of Utilization of financial amount exempted after the financial bidding of the tender process of the projects is completed.
7. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above,
8. Furnish the certified copy of Criteria of eligibility for CPWD as well as non-CPWD contractors in this project.
9. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
10. Furnish the certified copy of Completion certificate of the project.
11. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order (Order No. IPR/ADVT(Advt. Policy)-37/2016, Dated 30th January, 2018 by the Secretary to the Govt. of Arunachal Pradesh Information and Public Relations Department, Itanagar).
12. Furnish the certified Design and Scope of Work in the projects.
13. Furnish the certified copy of Work Specification of the projects.
14. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
15. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
16. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
17. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
18. Furnish the certified copy of Contractor Enlistment Order (Civil/Composite Category as per the nature of work), of tender participant and winning Firm.
19. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
20. Furnish the certified Integrity Pact submitted by the tender participant.

21. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 dated. 01-08-2018 and Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020).
22. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
23. Furnish the certified reasons & method adopt in TURNKEY/EPC Basis to execute this project.
24. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm.
25. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
26. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
27. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.
28. Furnish the Geo Coordinate information before the start of projects and after the start of the project mentioned above.
29. Furnish the certified Payment Details (Cheque no., voucher, PFMS etc. (Which ever method is used of payments)) of the project till date.
30. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
31. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
32. Furnish the certified Affidavit to invest cash up to (25% of tender value) submitted by the tender participant.
33. Furnish the certified copy of Utilization Certificate for the amount exempted in the NIT from the Total Sanctioned amount.

The following were present.

Appellant : Present. He states that he has not received any information from the PIO.

Respondent PIO : Present through VC. He has stated that the said schemes were not executed by them. He has requested the appellant to seek the information from the concerned PIO.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the FAA cum CE (E/Z) WRD Miao has heard and disposed of the first appeal filed to him on 18.06.2025 which directed the PIO to mention the concerned PIO under whose jurisdiction the projects were implemented. The PIO states that the information sought by the appellant is not available with them as it was not executed by them and it seems that the said schemes are of west Siang district.

Therefore, I find this appeal case fit to be closed at this court with a direction to the appellant to file a fresh application to the correct and concerned PIO, if required.

The appeal case is disposed of accordingly at this commission.
