## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sangkung Jonah, c/o DDSE Koloriang, District Kurung Kumey, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., O/o Directorate of Elementary Education, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/11/2024 regarding DPC & seniority list of all TGT.
- 2). The 2<sup>nd</sup> hearing was held on 6<sup>th</sup> May' 2025. Shri Tani Talom, the PIO-cum JDEE (EE), Govt. of A.P., O/o Directorate of Elementary Education, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Shri Sangkung Jonah, were present.
- 3). The Appellant had submitted that the PIO had furnished information just before the hearing and had requested to give few days to study the documents.
- 4). The Commission on appeal of the Appellant had directed the Appellant to intimate his satisfaction or dissatisfaction within 15 days from the date of issue of the order dated  $6^{th}$  May'2025, with a caution that the case shall be disposed of in case of failure to intimate.

- 5). The Appellant was given reasonable time to intimate his satisfaction or dissatisfaction regarding the information furnished by the PIO but till date the Appellant has not submitted any intimation to the Commission. The Commission hereby decides to dispose of the case.
- 6). Therefore, the case is hereby disposed of.
