Information sought:

The appellant filed an RTI application dated 20.01.2025 seeking following information regarding the implemented of development works under the Funding head of PMKSY/HKKP from 2018-2025.

Details of information Required: -

1. Give the Name Scheme/work List with Sanctioned Amount.

- 2. Furnish the Technical/Sanction order/Work Order copy/first & final bill/Billing voucher/LOC copy with details of payment like Xerox copy of Cheque leaf/demand draft/banker cheque/pay In slip for NEFT/RTGS/deposit Treasury Challan as per name of work order list wise.
- Give the Name of Contractor/Agency with its bank account number.
- 4. Give Colouring Photocopy of Geo-tag Report/CIB is mandatory of above-mentioned work wise.
- 5. Give the Money Receipt List of Contractor bill Payment with their name & contact number in name of work list wise.
- 6. Give the Xerox copy of Name of Agency/firm with contact number of Proprietor.
- 7. Give the billing Sheets/scheme Sheets details copy of work wise.
- 8. Give the MB records/Cashbook Statement.
- 9. How many percentages of amount has been deducted from contractor bill payment for like GST=%, CE=%, SE=%, EE=%, AE=%, JE=%, etc. Please Give the Exact amount deduction.
- 10. Give the Certified Colouring Photocopy of all the work Sites by EE WRD/.....
- 11. Give the Colouring photocopy/videography of every work site which might be before starting of work/Starting of work and ending of work.
- 12. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/Gaon buris of concern village/block.
- 13. Give Name of Officers & Officials with their Signature/Seal, who hold the DDO Power to approved the financial matter or carried out the Works.
- 14. Give details of Enlistment of contractor as per work department Rules Act 2008.
- 15. Give details of proprietor of firm/Registration of certificate.
- 16. Give the Money deposited Challan of Govt. account against GST/Royalty by department/firm in work wise.
- 17. All the bill Payment must be Paid to the Contractor Accurately as per amount which mentioned in the Sanctioned Order/Name of Scheme list.

ALL the document must be provided in CTC by Concern PIO.

Period from which information asked for: 2018-2025.

The following were present.

**Appellant**

**Respondent PIO** 

Present. He states that the information sought by the appellant is very voluminous and vague. He has produced a statement that the information sought is consisting of 215 schemes. The appellant has sought 17 items of information for each 215 schemes which makes voluminous. He also states that the FAA has heard the appeal case on 18.03.2025 and disposed of.

FAA

: Absent. Shri T. Rumi, EE (P&D) has represented the FAA. He states that the information sought by the appellant

is of very voluminous which is for the period from 2018 to 2025 for 215 PMKSY /HKKP schemes. Thus, it is not possible to engage more than 75% of the existing staffs diverting the resources of the public authority.

## **Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the FAA has heard the case on 18.03.2025 in which the appellant remained absent. In his judgement order the FAA has directed the appellant to file a fresh application to the PIO with seeking information for a one block year with respect to the information pertaining to the central scheme PMKSY / HKKP schemes.

In today's hearing also the appellant remained absent. The second appeal to commission was filed on 24.3.2025 i.e after the FAA has issued his judgement order. There is no mention about the judgement order of FAA by the appellant in his 2<sup>nd</sup> appeal. Thus, the commission has decided to upheld the Judgement Order dated 18.03.2025 passed by the FAA – the Chief Engineer (WRD), Eastern Zone, Miao and close this appeal case.

Accordingly, this appeal case is disposed of at this commission.
