Information sought:

i) Furnish the list of all funds sanctioned by State or central government under SJETA such as welfare schemes, tribal Development schemes, social justice schemes, base line survey for assessment, monitoring & evaluation of gap funding schemes, Innovative programme under support to TRI schemes, procurement of hardware and

software, support for e-office enrolment etc and many more carried out under SJETA Department in west Kameng Dist, A.P.

ii) Furnish the name of firm's and financial present status/progress reports of all the work carried out under SJETA in west kameng Dist, with year up to dated

iii Furnish names of all beneficiaries along with their proper submitted address, contact number, names and designation of board members with up to dated resolution, passed reports copy with proper Geo coordinate maps details number, photo and videography in colourful of before and after.

iv. Furnish details of full payment to contractor and beneficiaries by officially through department in system of draft/ cheque details and bifurcate payments details for separate work orders.

v) Furnish copy of all Advertisement details published by Concerned Department as per guidelines of appropriate government.

vi Furnish all requested documents in certified true copies only and if any documents are not Supplied as per my requirement, reply must be written or else I shall proceed to higher authorities of state.

Vi) As per INDIAN EVIDENCE ACT 74 AND 76 I have right to request for certain documents in seeking for and it is your obedient duty to supply my requirement documents without any further. delay or short of information.

viii) Furnish all documents details in specific year wise with separately. ix) Furnish all funds sanctioned for west kameng Dist AP only.

x) Furnish copy details of all proposal passed under SJETA for west kameng District with full documents details submitted from west kameng District under SJETA Department.

xi) Furnish list of all schemes and benefit funds to public by government of state or central with year wise guidelines details copy.

Period of which information asked for: 2018 to till date of application submitted.

Decision:
