2. Work order copy and name of the farm owner.
3. NOC order copy obtained from Director of Education Department.

Relevant facts emerged during hearing.

Previous Hearing :

First : 21.10.2024

In first hearing ordered as: "The Commission observes that PIO has already furnished the information. But the information sought at serial no.3 of the RTI

application is regarding the NOC obtained from the Director of Education, for which no specific reply is furnished by the PIO. The PIO is directed to furnish specific reply to appellant as to whether any NOC was obtained from Director Education, Govt. of AP. Furnish a copy of it, if obtained, to the appellant within one week from the date of issue of this order under intimation to this commission. The appellant is directed to serve a copy of this order to the PIO and obtain specific reply on serial 3 of the RTI application and submit a report to this commission".

Appellant : Absent. Submitted a written representation dated 26.08.2025 by representative of the appellant praying for dispose off of the appeal.

Respondent PIO : Absent

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, observes that the representative of appellant has submitted a letter dated 26.08.2025 requesting the commission for closure of the appeal case.
