The appellant filed an RTI application dated 09.01.2025 seeking all the relevant information against the utilization of fund under RE from 2016-2024 and also Specified the Name of Work under (RE-2021-22) are given below:

- 7. Give Xerox copy of Cheque leaf/Banker Cheque/RTGS/billing Challan/voucher of Contractor bill payment made by department as per the Name of work.
- 8. Give the MB/Cashbook Statement in work wise.
- 9. Give the Payment List of Contractor/Hand receipt with payee's name.
- 10. Give the various name of deduction amount from contractor bill payment as percentage as per the Govt. guidelines.
- 11. Give the Certified Colouring Photocopy of all the Work Sites by Concern Pio.
- 12. Give the Colouring photocopy/videography of every work site which might be before starting of work/Starting of work and ending of work.
- 13. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/buris of concern Segment/block.

- 14. Give Name of Officers & Officials with their Signature/Seal, who hold the DDO Power to approved the financial matter or handled the Works.
- 15. Give details of Enlistment of contractor as per work department Rules Act 2008.
- 16. Give details of proprietor of firm/Registration of certificate.
- 17. Give Money deposited Challan of Govt. account against GST/Royalty by department/firm.

ALL the document must be provided in CTC by Concern PIO.

i) Period from which information asked for: - 2016-2024.

Respondent PIO

: Present. He states that the information sought by the appellant cannot be furnished due to multiple schemes covering two Divisions i.e. Bomdila and Rupa Division. The First Appellate Authority has heard the appeal and passed an order.

FAA

- : Absent. Shri Kendo Zirdo (EE) has represented the FAA. He has produced a copy of judgement order passed by the FAA with following direction:
- (i) The appellant is directed to file a fresh application specifically to his jurisdiction i.e. Bomdila Electrical Division with mentioning specific schemes.
- (ii) The PIO is directed to furnish the required information as and when a fresh application is filed by the appellants specifically mentioning the schemes within his jurisdiction without fail.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that the FAA has heard the case on 11.03.2025 in which the appellant was absent. He has taken decision ex parte in absence of appellant. He has directed the appellant to file a fresh application to the PIO with specific scheme within his particular Division i.e. Bomdila Division. And the PIO shall furnish the required information as and when a fresh application is filed by the applicants specifically mentioning the schemes within his jurisdiction without fail.

In today's hearing also the appellant remained absent. The second appeal to commission was filed on 21.03.2025 i.e after the FAA has issued his judgement order. There is no mention about the judgement order of FAA by the appellant in his 2^{nd} appeal. Thus, the commission has decided to upheld the Judgement Order dated

11.03.2025 passed by the FAA – the Chief Engineer (Power), Western Electrical Zone, Itanagar and close this appeal case.

Accordingly, this appeal case is disposed of at this commission.
