ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Miss Bengia Mama, Dariya Hill Colony near Donyi Polo Road Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-Cum- District Agriculture Officer), Govt. of A.P., Pasighat, East Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding Composite farming at Banguk cultivation area in East Siang District, Arunachal Pradesh.
- 2). The 1st hearing was held on 2nd September 2025 (Tuesday) at 1100 hrs. Shri Opang Moyong, District Agriculture Officer, East Siang District, A.P was present through online mode. Miss Bengia Mama, Appellant was present in the court hearing.
- 3. The Appellant Miss Bangia Mama stated that she had received most of the information from the PIO but Sl. No. 19 as sought in Form "A" was not furnished by the PIO.
- 4. The PIO stated that Sl. No. 19 could not be furnished since the Monitoring team was not deputed by the concerned department SJETA, Itanagar; however, the project was completed.
- 5. The Commission directed the PIO-Cum- DAO, Pasighat to submit an "AFFIDAVIT" for Sl. No. 19 by giving correct, authentic statement and obtain seal and signature from the Notary Public. The Affidavit must be furnished to the Appellant within 15 days from the date of issue of this order through postal services or by using electronic media (through email and whatsapp) and endorse a copy to the Commission for records. Once the Affidavit is received from the PIO, the case shall be closed and disposed of. If not, then a hearing will be scheduled on a later date.
- 9). Hence, no next date of hearing will be fixed till the receipt of the Affidavit copy from the PIO by the Appellant.
