An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 170/2025.

APPELLANT : Shri Tamchi Gungte, Near KV-II School Itanagar.

RESPONDENT : The PIO, o/o the E.E, (RWD) Hayuliang Division
Anjaw District Govt. of A.P.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 29 (twenty nine) point information regarding c/o "LO29-NH113 Hayuliang Hawaii Road (Kamba) to Kongra (Km 6.00)" (12.41 cr)" during the financial year of 2024-25 by the PIO, o/o the EE, (RWD) Hayuliang Division Anjaw District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.11.24:

This appeal is heard for 2nd time today on 20.08.2025, the 1st time being on 30.05.2025 wherein both the PIO, Er. Shri Tame Tach, EE and the appellant, Shri Tamche Gungte were present in person.

This Commission, upon hearing the parties, then, directed the PIO to furnish the documents within one month and in any case before 02.07.2025 and the appellant was also directed to intimate this Commission of the receipt of the same within one week thereafter.

As directed the PIO furnished the requested documents to the appellant vide forwarding letter dt. 01.07.2025 a copy whereof has also been endorsed to this Commission. The appellant, however, vide his letter dt. 07.07.2025 intimated that the PIO has furnished him incomplete information as under:

- (i) Serial No.1(Sanction Order Copy) : *not authentic reply;*
- (ii) Serial No.6(Progress Report of the Projects) : *not a justified reply;*
- (iii) Serial No.8(Notice of NIT published Newspaper):*not a justified reply;*
- (iv) Serial No.9(Design and Scope of work) :*Incomplete document;*
- (v) Serial No.10(Work Specification of the projects) : *Not an authentic reply;*
- (vi) Serial No.11(Documents for Technical Bid):*The information is incomplete, no documents of other participants;*
- (vii)Serial No.13(Officers and their designation): *The information is incomplete;*
- (viii)Serial No. 14,17&18(contractor enlistment, affidavit and experience) : *No documents furnished;*
- (ix) Serial No. 24(Geo coordinate) : *Not proper reply.*

The appellant has, hence, requested for adjudicating the appeal with next date of hearing.

In the premises as above, this appeal is again listed today on 20.08.2025 wherein both the appellant, Shri Tamchi Gungte and the PIO, Er. Shri Er. Shri Tame Tach, with the requested information / documents, are present in person.

The documents /information brought in by the PIO is handed over to the appellant who, however, complained that the copy of sanction order is still not being furnished by the PIO. The PIO on the other hand submitted that the project in question was implemented on the basis of the amount allotted by the GoI and the Technical sanction and that there was no other sanction order. The appellant, however, contested by saying that he has got the proof of sanction order having been issued in similar project by the CE (RWD) (PMGSY) as sanctioned by the Secretary (RWD) -cum- the Chief Executive Officer, ARRDA, Govt. of A.P, a copy of order dt. 10.08.2023 whereof has also been produced by him. The PIO then assured that he will find out the sanction order in the o/o the CE (RWD) (PMGSY) and if found will furnish the same to the appellant.

This Commission upon hearing the parties and on perusing the copy of sanction order dt.10.08.2023 issued by CE (RWD) (PMGSY) in respect of some other project, directed the PIO to trace out the copy of sanction order in respect of the project in the instant case and furnish it to the appellant within one week from the date of receipt of this order and further directed that if no such sanction order besides the GoI's allotment order and the technical sanction order was issued in implementing the project then he shall declare so by way of an affidavit.

The appellant is also directed to go through the rest of the documents and report this Commission within one week about his satisfaction for further consideration of this appeal.
