ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Johan, Adv Tarh Taram, Shri Gollo Laninag, Doimukh, PO/PS Doimukh, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P., O/o Itanagar Municipal Corporation (IMC), Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/10/2024 regarding c/o road and steel girder bridge for solid waste management treatment plant at Dapor Yarlo (Hollongi) Itanagar.
- 2). The 3rd hearing was held on 6th May' 2025. Shri Kipa Gagung, The PIO-cum-EE(IMC) , Govt. of A.P., O/o Itanagar Municipal Corporation (IMC), Itanagar, Papum Pare District, Arunachal Pradesh was represented by Adv. Tapo Omo. The Appellant Shri Nabam Johan had appeared before the court after the hearing of the case.
- 4). The Commission had directed the representative of the PIO to contact the Appellant and hand over the information within fifteen days from the order dated 6th May'2025. The mobile Nos. of the Appellant (9436847717 & 825848823) was provided to the representative of the PIO for communication.
- 5). The Commission had directed the Appellant to visit the office of the PIO and collect the information and intimate his satisfaction within fifteen days from the date of issue of order dated 6th May'2025, failing which the case would be disposed of.

6). The Appellant was given reasonable time to intimate his satisfaction or dissatisfaction regarding the information furnished by the PIO but till date the Appellant has not submitted any intimation to the Commission. The Commission hereby decides to dispose of the case.

7). Therefore, the case is hereby disposed of.
