ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the EE, (RWD) Hayuliang Division Anjaw District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.11.24:

Particulars of sought information are given below:

1. Furnish the certified Sanction Order Copy.
2. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender participant issued by the Competent Authority regarding domicile status with the districts as per Rule 4 (ii) (b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
3. Furnish the certified LOC Copy with respect to the subject mentioned above.
4. Furnish the certified copy of Utilization Certificate.
5. Furnish the certified copy of Notice Inviting Tender (NIT) With respect to the subject mentioned above.
6. Furnish the certified Progress Report of the Projects in physical and financial section till date.
7. Furnish the certified copy of Completion certificate of the project.
8. Furnish the certified copy of Newspaper in which NIT was published (Atleast 3 newspaper name (One National & 2 Local) along with date of publication of newspaper, as per Government approved order.
9. Furnish the certified Design and Scope of work in the project.
10. Furnish the certified copy of Work Specification of the projects.
11. Furnish the certified copy of documents submitted by tender participate for Technical Bid.
12. Furnish the Name of firms who won the tender work with respect to the subject mentioned above.
13. Furnish the name of officers and their designation at the time of monitoring the work.

14. Furnish the certified copy of contractor Enlistment Update reports (Civil/Composite Category as per the nature of work), of tender participating and winning firm.
15. Furnish the certified copy of EMD and Security money deposited by all the tender participation.
16. Furnish the certified Integrity Pact submitted by the tender participant.
17. Furnish the certified Affidavit copy Sworn before a competent Magistrate to the effect that he /she (tender participant), does not have 2 (Two) more incomplete ongoing commitment (projects/contact to execute) at the time of bidding by the tender participant and winning firm. (As per rule SPWD/W-66/2012 dated.01.08.2018 as per District Based Entrepreneurship Act, 2015& 2020.
18. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less than 60% of the estimated cost or Completed one similar work of value not less than 80% of the estimated cost along with the completion certificate issued by the Engineer in charge duly countersigned by the concerned Superintending Engineer and Chief Engineer , in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
19. Furnish the certified reasons & provision to adopt TURNEY/EPC Basis to execute this project.
20. Furnish the certified copy of Acceptance letter for tender work by the Executing Agency to the tender winning firm.
21. Furnish the certified copy of work order given to the contractor by the Executing Department.
22. Furnish the Agreement Copy made between the contractor and the Executing Agency for the projects mentioned above.
23. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy paper) after completion of work.
24. Furnish the Geo Coordinate information for the work mentioned above.
25. Furnish the certified Payment Details (Cheque no. voucher, PFMS etc. (which ever method is used of payments) of the project till date.
26. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
27. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
28. Furnish the certified Affidavit to invest cash upto (25% of tender value) Submitted by the tender participant.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Tamchi Gungte had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the Chief Engineer

(RWD), (PMGSY), Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 27.12.2024. However, the appellant apparently, failed yet again to obtain the information. Hence this 2nd appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide Memo of Appeal dated 17.02.2025.

This appeal is, accordingly, is listed today on 30th May, 2025 for hearing wherein both the PIO, Er. Shri Tame Tach, EE and the appellant, Shri Tamche Gungte are present in person.

Heard the parties.

The appellant, reiterating his demand for the requested information from the PIO, pleaded for appropriate direction to the PIO to furnish the same.

The PIO submitted that he received the summons notice only on 27.05.2025. As such the requested documents/ information could not be readied and further that he has instructed his APIO to collate the documents for furnishing to the appellant at an early date and sought one month time to which the appellant has no objection.

This Commission considered the request of the PIO and directs him to furnish the documents within one month and in any case before 02.07.2025 and the appellant shall, thereafter, within one week intimate this Commission of the receipt of the same failing which this appeal shall stand closed.
