An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-316/2025

APPELLANT : Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Nammdu.
RESPONDENT : The PIO, o/o the Executive Engineer (E), Basar Electrical Division, Lepaprada District (A.P)

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram & 2 others for non-furnishing of below mentioned information by the PIO o/o the Executive Engineer (E), Basar Electrical Division, Lepaprada District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 03.01.2025.

- A) Particulars of information:** To furnish all the relevant information against the following name of work list as per your earlier furnished information SL No. 1 Purchase of Electrical Distribution materials and Transformer during financial year 2017-18
1. Construction of dedicated 11kv line from 2x2.5 mvA,33/11kv switchyard Gori to Govt. model village with LT Network including installation of 100kvA,11/0,433kv Distribution transformer under Leparada district.
 2. Replacement of 2.5mvA33/11kv transformer i/c accessories and special repair of control panel and switch gears of 2x2.5mvA33/11kv sub-station.
 3. Extension of 11kv line for electrification of Lahio Renyi,rukin Bogdo and Raga village, Eshi-chiku village i/c providing of Distribution transformer sub-station under Basar electrical division SIDF Procurement of 11kv, HTOH Line materials financial year 2016-17.
 4. Extension of 11kv line for electrification of Lahio Renyi, rukin Bogdo and Raga village, Eshi-chiku village i/c providing of Distribution transformer sub-station under basar electrical division SIDF Procurement of 11kv,HTOH Line materials financial year 2018-19.
 5. Development of colonies for Staffs and officers including Revenue collection centers in and around power sub-station and distribution centre under Aalo electrical circle.
 6. Replacement of rusted HT/LT Poles under Aalo electrical circle SADA -2017-19
 7. Replacement of rusted HT/LT Poles under Aalo electrical circle SADA -2017-18
 8. Extension and upgradation of such T&D System at Tirbin and Basar electrical sub division under Basar providing street light fitting from Shiy- Mandir to kagu Gamgi under Funding head of SIDF 10.

9. Development of colonies for Staffs and officers including Revenue collection centers in and around power sub-station and distribution centre under Aalo electrical circle (S.H: c/o 5 five men bachelor barak at Basar.
10. Development of colonies for staffs and officers including Revenue collection centres in and around power sub-section and distribution centre under Aalo electrical circle (AED) baE& RuED (SH-C/o Revenue counter and JE (Officer Tirbin under Baed.
11. C/o Special & Preventive repair of 2x2.5 mVA33/11kv Basar power sub-station i/c provision of Breakers etc.
12. Construction of 11kv dedicated line with L.T network from Soi village to EB Project at kaben putu i/c installation of 63kvA,11/0.415kv DT under Leparada District.

B) Details of information Required:

1. Name of Scheme/Work list/DPR Copy/Coloring Photocopy of Geo-tag Report of every work site.
2. Copy of work order/sanction order copy with annexure details moods of contractor/firm payment like Cheque leaf/demand draft/banker cheque/RTGS slip by department as per the Name Scheme/work list wise.
3. Money Receipt of Contractor/firm Payment list as according to the name of Scheme/Work list wise with their Signature and contact number.
4. Xerox copy of firm/Enterprise Trading Licence.
5. First & final bill copy of all the works with enclose details of payment like Cheque leaf/demand draft/banker cheque/RTGS slip/billing voucher/challan of contractor/firm by department as per the Name of Scheme/work list wise.
6. Billing detail sheet/scheme detail Sheets copy of work wise.
7. Xerox copy of Cheque leaf/Banker Cheque/RTGS/billing Challan/voucher of Contractor/firm bill payment made by department as per the Name of Scheme/work list/work order wise.
8. MB/Cashbook Statement in work wise.
9. Payment List of Contractor/firm/Hand receipt with payees name.
10. Various name of deduction amount from contractor/firm bill payment as percentage as per the Govt. guidelines.
11. Certified Coloring Photocopy of all the Work Sites by Concern Pio.
12. Coloring photocopy/videography of every work site which might be Before starting of work/Starting of work and Ending of work.
13. NOC copy of ZPC/ZPM/GPC/Gaon buras/buris of concern Segment/block.
14. Name of Officers & Officials with their Signature/Seal, Who hold the DDO Power to approved the financial matter or handled the Works.
15. Details of Enlistment of contractor as per work department Rules Act 2008.
16. Details of proprietor of firm/Registration of certificate.
17. Money deposited Challan of Govt. account against GST/Royalty by department/Firm. ALL the document must be provide in CTC by Concern PIO.

Brief facts and decision :

Records emerging from the appeal disclose that the appellants, Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to file appeal before the Chief Engineer (Electrical), Central Zone, Govt. of A.P, Namsai, as the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 17.02.2025.

Records, however, further reveal that the Chief Engineer (Power), Central Electrical Zone, Itanagar, the FAA had conducted the hearing on 12.04.2025 having been redirected to it by the o/o Chief Engineer (Electrical), Central Zone, Govt. of A.P, Namsai, on 21.03.2025. The FAA, vide order dt. 21.4.2025, after hearing the parties had passed the following order:

“Hearing:

The appellants/complainants, Adv. Riya Taram, Adv. Bengia Tahar and Mr. Lokam Namdu were absent from the hearing. The respondent, Shri Boku Basar, PIO-cum-EE (E), Basar, attended the hearing in person.

The respondent reported that the required documents were brought to the hearing, but due to the absence of the appellants, he was unable to hand over the documents. The respondent further assured that the documents would be provided to the appellant as soon as they approached him.

Decision:

After considering the matter, the appeal is disposed of. The respondent, PIO-cum-EE(E), Basar, is hereby directed to sent the documents to the appellants by post on the next working day.

If the appellants are not satisfied with this decision, they may file a further appeal before the Chief Information Commissioner, Government of Arunachal Pradesh, Itanagar, within the stipulated time.”

Further records, however, disclose that the appellants filed their 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 08.04.2025 which has been registered on the same date in the Commission.

This appeal is, accordingly, listed and heard today on 22nd August, 2025 wherein the PIO is represented by Shri G.Lombi, Head Assistant, o/o the EE (E), Basar Division but the appellants are absent without any intimation.

Heard Mr. G.Lombi who submitted that in compliance with the order of the FAA, the o/o the PIO had already dispatched the requested documents to the appellants through the Post Office in support of which he has produced the copy of tracking record of the parcel issued by the Rama Krishna Mission Post Office dt.24.04.2025 showing the delivery of the parcel to BO, Jully. However, the actual delivery of the parcel to the appellants could not be ascertained.

Since the appellants are absent in the hearing, it could not be confirmed as to the actual receipt of the documents by them. This Commission, therefore, deems it appropriate to direct the appellants to intimate this Commission of the receipt of the documents within 1(one) week from the date of receipt of this order for further consideration of the appeal failing which this appeal shall be closed without any further order.
