**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Dengo Mimi, Tribal Colony, Mimi Complex, Tezu, Lohit District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-District Agriculture Officer (DAO), Govt. of A.P., Tezu, Lohit District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 21/05/2025 regarding procurement and distribution of fertilizers and micronutrients under the National Mission for Edible Oils- Oil Palm (NMEO-OP) earlier known as NFSMO-OP.

2). The 1<sup>st</sup> hearing was held on 2<sup>nd</sup> September' 2025 as scheduled. Shri Nyage Loya, PIO-cum-District Agriculture Officer (DAO), Govt. of A.P., Tezu, Lohit District, Arunachal Pradesh was present and the Appellant was represented by Adv. Ashomi Linggi.

3). Representative of the Appellant submitted that the PIO had not furnished any information.

4). The PIO informed the Commission that the information sought by the Appellant was voluminous since it covers the period from 2019 to 2025. Therefore, had asked the Appellant to seek specific information according to decision of Commission vide Memo No. CIC/09/2016/103 dated 8<sup>th</sup> May'2024, but till date no reply had been received from the Appellant.

5). The Commission apprised the PIO that the above decision had been superseded by Noticed issued vide Memo No. CIC/09/2024/418 dated Itanagar, the 19/11/2024. At the same time advised the Appellant to exercise prudence and wisdom while seeking information and that only relevant information should be sought. The Commission, also, directed the PIO to furnish all information which are readily available and not exempted under the provision of the RTI Act, 2005. In case part of information sought are not available, justifiable reasons should be given through AFFIDAVIT.

6). The PIO was directed to furnish information and/or AFFIDAVIT if applicable within one month (30 days) from the date of issue of this order, failing which under section 20(1) of the RTI Act, 2005 penalty would be imposed against the PIO. The Appellant was also asked to intimate the Commission in writing, his satisfaction or dissatisfaction after receipt of information.

7). The next date would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given to the PIO the case would be disposed of.
