ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing 13(Thirteen) point information on c/o "Improvement of water supply system for Menchuka Township and Peripheral village etc....." by the PIO, o/o the Executive Engineer (PHED) Menchuka Division, Shi-Yomi District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.09.2024.

Hearing and decision:

This Appeal was, accordingly, listed and heard on 2nd April, 2025 wherein both the Appellant, Shri Tamchi Gungte and the PIO, Er. Shri Tung Sono, EE (PHED) Menchuka Division were present in person.

This Commission, upon hearing the parties and on perusal of the records found that the First Appellate Authority (FAA) did not adjudicate on this appeal and, therefore, this appeal was remanded to the First Appellate Authority for adjudication and passing an appropriate order.

In compliance with the order of this Commission, the FAA had conducted the hearing on 11.04.2025 and passed the following order:

"Findings:

Upon perusal of the records and after hearing both parties, it is observed that:

- The PIO has not yet furnished the requested information to the appellant.*

4. Order:

In view of the above, it is held that the information sought under the RTI Act has to be furnished to the appellant today i.e on 11.04.2025.

- The PIO has complied and duly furnished the requested information to the appellant vide communication.*
- The appellant has acknowledged receipt of the said information and confirmed during the hearing that the same is satisfactory and no further grievance remains.*

No further direction is required in the matter.

Accordingly, the appeal is disposed of."

Meanwhile the appellant, vide his letter dt. 16.04.2025 intimated that the PIO has furnished him the requested information but were incomplete information as under:

- (i) Serial No. 4 (publication of NIT in N/paper): *the information is incomplete;*
- (ii) Serial No.5(Tender Evaluation Technical Bid) : *The information furnished is not Proper and*
- (iii) Serial No. 11(copy of contractor Enlistment Update Reports) : *did not furnish the documents.*

This appeal was, therefore, listed and heard again today on 22nd August, 2025 wherein the appellant and the Er. Shri Dorik Bagra, ASW-cum-APIO, with the left out documents are present in person.

The documents brought in the APIO has been handed over to the appellant who expressed his satisfaction on the same except for the Serial No.11 relating to the contractor Enlistment Update Reports. When queried, the APIO submitted that since the terms 'the Contractor Enlistment' and 'Contractor Registration' are the one and same, the Contractor Enlistment Certificate was not obtained from the contractors.

This Commission, upon hearing the parties and on perusal of the documents furnished by the APIO, directs the APIO to furnish a declaration in writing that the Contractor Enlistment Certificate was not obtained from the contractor at the time of tendering process as the Contractor Enlistment and Contractor Registration are the one and same within one week from the date of receipt of this order.

This appeal is disposed of and closed above terms.
