ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram & Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer (RWD)(PMGSY) Govt. of A.P, Itanagar as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 03.12.2024

A) <u>Particular of information:</u> To furnish information regarding Vibrant Village Programme Project 2024-25 under Kurung Kumey District (A.P)

B) Details of information required:

- 1. Total No. of project with the Sanction order copy;
- 2. Total list of tender participant in each project sanctioned under VVP;
- 3. Tender Evaluation copy of all tender participant of all the projects.
- 4. Tender winning firm against all the project sanctioned under VVP program;
- 5. Name of place where the tender process was conducted along with date and time;
- 6. List of the tender committee during the tender process;
- 7. The video recording/ coloring photograph of tender process/committee;
- 8. The note sheets submitted by the Local MLA, & CMO Office to award a tender work to the particular contractor participant as an election Liabilities and
- Reason behind the delay of the tender result which was conducted on 14th. March, 2024.

Hearing and decision:

The appeal was heard for the 2nd time today on 05.09.2025 the 1st time being on 30.07.2025 wherein one of the Appellants, namely, Shri Tamchi Gungte and the APIO, Likha Tei, Draughtsman were present in person.

The appellant *then submitted that the PIO had furnished the requested documents/ information except the copies of sanction order. The APIO, however, submitted that the documents furnished to the appellant also include the copies of sanction order which are mentioned against each of the projects. He, however, submitted that more detailed clarification could be obtained from the EE of the Division concerned i.e EE(RWD), Laying Yangte.

The PIO was, therefore, directed to collect the detailed clarification from the Division concerned and furnish the same to the appellants within 30th August, 2025. The EE(RWD), Laying Yangte was also directed to furnish the clarification / explanation in writing to the PIO, PIO, o/o the Chief Engineer (RWD)(PMGSY), Itanagar in terms of the provisions of sub-section (5) of section 5 of the RTI Act.

This appeal was, thus, listed again today on 05.09.2025.

Today the EE(RWD), Laying Yangte Division is represented by Shri Rohit Sanyasi, LDC with the documents while Shri Tamchi Gungte, one of the appellants is present in person.

The appellant, Shri Tamche Gungte who was handed over the documents (copies of sanction order), complained that the documents brought in by the representative of the EE, Laying Yangte are the sanction/allotment order issued by the GoI and not that of State Govt. The presentative of the EE, Laying Yangte, on the other hand, submitted that the appellants in their RTI application itself did not specifically indicate as to the sanctioning authority, whether the GoI or the State Govt.. He, however, assured that the copies of the administrative approval and expenditure sanction issued by the competent State Govt. Authority in respect of the project in question will be furnished to the appellants.

This Commission, upon hearing the parties, directs the PIO (RWD), Laying Yangte Division to furnish the copies of sanction order issued by the State Govt. in respect of the project in the instant case to the appellants within 1(one) week from today with intimation to this Commission and the appellant shall report the receipt of the same to this Commission within 2(two) days of the receipt failing which this appeal shall stand closed.
