ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Konsa.
- 2). The 1st hearing was held on 2nd September' 2025 as scheduled. Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, PIN-792131 and the Appellant Shri Wangnon Wangnow were present.
- 3). The Appellant submitted that the following information had not been furnished:
 - a). Sl.no. 2: Payment details.
 - b). Sl.no. 4: Completed work with photographs of before and after work, and geo tags.
 - c). Sl.no. 11: Letter of Credit.

The Appellant also appealed for furnishing of all the information afresh.

- 4). The PIO informed the Commission that he was ready to furnish all available information and the he had invited the Appellant to visit the office and sort out the issues; but, the Appellant did not accept his offer; instead asked to meet in the Court. The PIO also informed that the project was ongoing and is yet to be completed; and that there was no letter of credit.
- 5). The Commission asked the Appellant to visit the office of the PIO to sort out the issues and get the relevant information from the PIO. The Commission also directed the PIO to furnish complete information to the Appellant within fifteen days from the date of issue of this order, failing which penalty under section 20(1) of the RTI Act, 2005 shall be imposed on the PIO.

- 6). The Appellant was asked to intimate the Commission his satisfaction or dissatisfaction within twenty days from the date of issue of this order, failing which the case would be disposed of.
- 7). The next date of hearing would be fixed on the basis of the input from the Appellant or the case would be disposed of on expiry of the time stipulated.
