Information sought:

The appellant filed an RTI application dated 13.11.2024 seeking following information regarding

1. Construction of 2880 MW Dibang Multipurpose Project by NHPC, Rs. 384.468 lakhs (State CAMPA)
2. Joram-Koloriang Road (70-138 KM), Rs. 53.345 lakhs (State CAMPA).
3. BCT (36-50 KM) Amortala-RF, Rs.440.712 laksh (State CAMPA)

Details of Information required:

- i. Furnish the certified copy of sanction order and work order issued against the particular firms.

- ii. Furnish the certified copies of newspaper cutting of advertisement of NIT and total number of bidders in bidding process, letter of acceptance and agreement copies.
- iii. Furnish the certified copies of photographs of physical achievement and present status of plantation/work sites area.
- iv. Furnish the certified copy Utilization Certificate of said schemes.
- v. Furnish the certified copies of documents submitted by the executing firms.
- vi. Quotation related to the procurement for aforesaid schemes, and also furnish cheque leaves, counter foils and GST invoice copies.
- vii. Furnish the Cash Book Register.

Period for which information asked for: 2023-24.

First Hearing : 03.04.2025
Second Hearing : 14.07.2025

In second hearing ordered as: *"The Commission observes that the PIO's reply to the appellant's RTI query at serial no. (ii), (v), (vi) and (vii) is vague and not specific. The appellant has not asked about the disbursement of the amount in his RTI query. The PIO is directed to furnish to the point and specific information as per information query at serial no. (ii), (v), (vi) and (vii) filed by the appellant within two weeks from the date of issue of this order i.e. on or before 28.7.2025 under intimation to this commission. The appellant is directed to contact the PIO / office to collect the information within the stipulated time and submit a report to this commission".*

The following were present.

Appellants : Absent. Counsel of the appellant Adv Dope Ori represented the appellant. He submits that an information letter dated 30.07.2025 received from the DFO Khellong Forest Division in compliance of interim order of this commission date 14.07.2025. He sought clarification regarding disbursement of CAMPA fund to the RFO without floating tender / call of quotation in the form of Civil Advance disbursement.

Respondent PIO : Present through VC. She states that since the said CAMPA fund is disbursed to Range Forest Officers in the form Civil Advance for execution of the work departmentally no tender / quotation called. As such there is no NIT and press publication.

On interjection, the PIO has agreed to furnish to appellant the means of documents vide which the Civil Advance was disbursed to the Range Forest Officers as reply to query serial no. (vii) in RTI application in form – A.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that all the information has already furnished to the appellant except the information at serial no. (vii) in the RTI application. The PIO is directed to furnish the information within 2 weeks from the date of issue of this order pertaining to serial no. (vii) including the documents / cash book and means of Civil Advance disbursement to RFO under intimation to this commission. The appellant shall submit a report to this commission after obtaining the aforesaid information within one week on receipt of information from the PIO.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no such compliance report is received from the appellant and PIO within stipulated time this appeal case shall stand closed.
