**SHOW CAUSE NOTICE**

**{ Section 19(8)(b) & (c) r/w section 20 of the RTI Act, 2005}**

To

Er. Shri Nagram Logu, APO,  
o/o the PD (RD), Kloloring,  
Kurung Kumey District,  
Arunachal Pradesh.

1. WHEREAS Shri Pisa Tapam, Dokum Colony, Naharlagun, the appellant in APIC Case No. APIC-431/2024 had filed application dt. 22.08.2024 before the PIO, o/o the PD (RD) Koloriang, Kurung Kumey District Govt. of Arunachal Pradesh , requesting for the following documents / information under section 6(1) of the RTI Act, 2005:

**Name of the scheme:**

1. PMKSY -WDC 2.0 IV/2021-22 at Rengchi (1000), Pakba(500) and Rite(500) villages under Koloriang;
2. PMKSY -WDC 2.0 IV/2021-22 at Nyobiaring at Chello, Dunting at Nangram, Ampornge & Hurh at Yapak and Maba at Tayeng village under Koloriang.

**A.Details of information required:**

1. Technical sanction order copy.
2. Name and address of contractors/firm/name of Firm owner/proprietor.
3. NIT copy if possible.
4. Details bid documents of contractor (Technical & Financial).
5. Name of work with Geo tag report of each project.
6. Details of payment with money receipt of contractors i.e. cheque book, counter foil/deposit Challan.
7. Account statement of department.
8. DPR copy.
9. MB book.
10. First and final bill.
11. Photocopy of work site from starting to end / certified photocopy of work site by the concern officer.

**B.Period for which information asked for: 2021-22**



2. AND WHEREAS Shri Pisa Tapam failed to obtain the requested information which prompted him to appeal before the Deputy Commissioner, Koloriang, Kurung Kumey District, Arunachal Pradesh as the First Appellate Authority (F.A.A) under Section 19 (1) of the RTI Act vide his Appeal Memo dated 04.10.2024. But having failed yet again to obtain any response from the PIO or the FAA he filed his 2<sup>nd</sup> appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.10.12.2025.

3. AND WHEREAS this appeal was, accordingly, listed for 5 (five) times on 04.04.2025, 23.04.25, 21.05.25, 06.06.2025 and 11.07.2025.

4. AND WHEREAS the PIO, o/o PD (RD), Koloriang Er. Shri Nangram Logu, APO did not appear in any of the hearing dates despite summons without any intimation except for the hearing on 21.05.2025 when he informed during the hearing that due to his pre-occupation in an enquiry being conducted by the Anti Corruption Bureau (formerly SIC) in a 15<sup>th</sup> Finance Commission Fund related case he will not be able to attend the hearing. The PIO, however, submitted then that the requested documents/information shall be provided to the appellant by 30<sup>th</sup> May, 2025.

5. AND WHEREAS in the hearing fixed on two subsequent dates i.e on 06.06.2026 and 11.07.2025 also the PIO did not appear

6. AND WHEREAS Shri Pisa Tapam informed in the hearing on 11.07.2025 that the PIO, despite his assurance given on 21.05.2025, did not furnish the requested information. And when asked as to whether he tried to contact the PIO, the appellant, Shri Pisa Tapam stated that he tried to contact him over phone but the PIO never picked up the call.

7. AND WHEREAS this Commission has taken a very serious view of your absence in the hearings which amounted to your blatant and willful disrespect to this Commission and the RTI regime attracting the penal provisions of section 20 of the RTI Act 2005.

8. NOW THEREFORE this notice is issued to you under section 19(8)(b) and (c) to show cause as to why action should not be taken against you as provided under section 20 of the RTI Act, 2005 for violation of the provisions of section 7 (1) of the RTI Act and showing willful disrespect to this Commission and you are directed to appear in person before this Commission on **21.07.2025 (Monday)** at 10.30 am along with the documents / information sought by the appellant, Shri Pisa Tapam and also the reasons for your absence from the hearings.
