**SHOW CAUSE NOOTICE**

**{ Section 19(8)(b) & (c) r/w section 20 of the RTI Act, 2005 }**

To

Shri Gollo Tara, E.E -cum-PIO,  
RWD, Sagalee Division, Papum Pare District,  
Arunachal Pradesh.

1. **WHEREAS** Shri Nabam Tapak, the appellant in the APIC case No.637/2023, vide his application dt.24.04.2023 had requested the PIO, o/o the Executive Engineer (RWD) Sagalee Division for seeking details of information on 36(thirty six) points as annexed in his application relating to construction of Yazali-Sakiang Road from 40 KM point to Pilla for period 2015-2019.
2. **AND WHEREAS**, having failed to obtain the sought for information from the PIO, the applicant filed his 1<sup>st</sup> appeal under section 19(1) of the RTI Act, 2005 before the First Appellate Authority, the Superintending Engineer (RWC), Govt. of A.P,Vivek Vihar, Itanagar vide his Memo of Appeal dt.16.06.23. But having failed yet again to receive any response from the First Appellate Authority, the Appellant preferred his Second Appeal under section 19(3) of the RTI Act vide his Appeal Memo dt.12.07.2023 which had been registered in the State Information Commission as APIC No.637/2023 dt. 13.07.2023.
3. **AND WHEREAS**, the hearing of this appeal was fixed for 4(four) times on 19.06.2024, 24.07.2024. 23.08.2024 and 11.09.2024 and summons were issued to you accordingly to appear in person vide summon notices dt.29.05.2024, 21.06.2024, 26.07.2024 and 27.08.2024.

4. **AND WHEREAS**, despite the summon notices you failed to appear even in a single hearing or depute anyone to represent you in the hearings.
  
5. **AND WHEREAS**, this Commission taking a serious view of your absence in the hearings which amounted to your blatant disrespect to this Commission and the RTI regime, decided, vide order dt.12.09.24, to issue notice to you to show cause as to why action should not be initiated against you as provided under section 19(8)(b) and (c) r/w 20 of the RTI Act, 2005 for violation of the provisions of section 7 (1) of the Act.
  
6. **NOW THEREFORE**, you are directed to appear in person before this Commission on 4<sup>th</sup> October, 2024 at 10.30 am along with the information(s) sought by the appellant, Shri Nabam Tapak and also the reasons for your absence from the hearings.
