Sub: Show Cause Notice for Non-Compliance of Judgment Order, Dated 21st January' 2025, in the APIC Appeal No-143/2024

Dear Public Information Officer (PIO)-cum-Executive Engineer, PWD, Dirang Division.

Whereas, this notice is issued to you in your capacity as the Public Information Officer (PIO)-cum-Executive Engineer, PWD of the Dirang Division concerning the non-compliance of the judgment order delivered by the State Information Commission, Government of Arunachal Pradesh, dated **January, 21st 2025**, in the appeal bearing **APIC-No143/2024**.

Whereas, it has come to our attention that you have failed to provide the requested information to the Appellant as mandated by the said judgment under the Right to Information Act, 2005. Specifically, the order instructed that the requested information be furnished to the Appellant within one week from the date of the judgment order.

Whereas, this non-compliance is viewed with serious concern, as it undermines the effectiveness of the RTI, Act and the transparency it aims to promote. It is imperative that you provide a written explanation as to why an appropriate action should not be taken against you for this failure to comply with the judgment order.

NOW THEREFORE,


You are hereby directed to Show Cause within **15 days** from the receipt of this notice as to why action against you should not be initiated as provided in Section 20(2) of the RTI, Act, 2005. Your explanation should clearly outline the reasons for the delay in compliance, along with any supporting documentation that may pertain to this matter.

Failure to respond adequately within the stipulated time frame may result in further action as per the provisions of the Right to Information Act and applicable rules governing the conduct of PIOs.

Please treat this matter with due urgency.
