SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

WHEREAS, Shri Lokam Namdu Tania filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, **on 16/06/2023 U/S 19 (3) of RTI Act, 2005** vide Appeal No. **APICS-554/2023**, wherein, alleging against you that you failed to furnish information sought by the Appellant under Form-A of his application dated **28/03/2023** relating to the matter as quoted in Form-A application.

WHEREAS, you, being PIO-cum-Executive Engineer (PHE & WS), Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant **within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under the sub section (1) of section-20 of the Act.**

WHEREAS, date of hearing of the Appeals was intimated to you well in advance but you are found absent consecutively in six hearings on **16/10/2023, 04/12/2023, 22/01/2024, 03/04/2024, 12/06/2024** and without intimation to the Commission. The Commission viewed seriously on the repeated absence of the PIO and showing reluctance attitude to appear before the Commission in every hearing, inspite of the directions of the Commission and **failed to furnish the information within prescribed period.**

NOW THEREFORE, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the reply of Show-Cause Notice against you on or before 4th **September, 2024 at 2 PM** under Section-20 of the RTI Act for violation of **Sub Section (1) of the Section-7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.**
