**Sub: Show Cause Notice for Non-Compliance of Judgment Order, Dated 11<sup>th</sup> February' 2025, in the APIC- Apeal No-237/2024/**

**Whereas**, the Appellant Shri Takam Dado Kagung has submitted a written complaint against you for non-compliance of the Judgement order of the Commission on 13<sup>th</sup> March' 2025.

**Whereas**, this notice is issued to you in your capacity as the Public Information Officer (PIO)-cum-DFO, Kra-Daadi Forest Division, concerning the non-compliance of the judgment order delivered by the State Information Commission, Government of Arunachal Pradesh, dated 11<sup>th</sup> February' 2025, in the appeal bearing APIC-No. 237/2024.

**Whereas**, it has come to our attention that you have failed to provide the requested information to the Appellant as mandated by the said judgment under the Right to Information Act, 2005. Specifically, the order instructed that the requested information be furnished to the Appellant within 30 days from the date of the judgment order.

**Whereas**, this non-compliance is viewed with serious concern, as it undermines the effectiveness of the RTI, Act and the transparency it aims to promote. It is imperative that you provide a written explanation as to why an appropriate action should not be taken against you for this failure to comply with the judgment order, under the provision of RTI, Act, 2005.

**NOW THEREFORE,**

You are hereby directed to Show Cause within **15 days** from the receipt of this notice as to why action against you should not be initiated as provided in Section- 20(1) or 20(2) of the RTI, Act, 2005. Your explanation should clearly outline the reasons for the delay in compliance, along with any supporting documentation that may pertain to this matter.

Failure to respond adequately within the stipulated time frame may result in further action as per the provisions of the Right to Information Act and applicable rules governing the conduct of PIOs.

Please treat this matter with due urgency.
